How to use the manning agent application form

The application form for endorsement of foreign seafarer's certificates for service on board Norwegian ships is primarily meant to be used by manning agents serving Norwegian shipping companies. The form may be used by Norwegian foreign service missions and seafarers that have no manning agents or Norwegian Consul in reasonable vicinity.

If used by Norwegian foreign service missions or Consuls they will have to undertake the manning agent's responsibilities and duties.

If used by a seafarer (only in certain circumstances), the shipping company is responsible for checking all information on the seafarer that would normally be delegated to the manning agent.

Select whether the application is a duplicate or a first time application. All applications that are not a duplicate are considered to be a first time application.


In the upper dropdown list select the correct group of certificate.

All groups marked STCW 1978 are after STCW 1978 as amended by Manila 2010.

In the next dropdown list select the actual certificate to which the application applies.

In the bottom dropdown list, select the shipping company where the seafarer will be employed. The company will receive the application for approval in their inbox in the Altinn system.
